


Born in Karlsruhe in 1965, Kapferer studied administrative sciences at the University of Konstanz. He launched his career at Germany's Free Democratic Party (FDP), where among other things he headed up the Strategy and Campaign Department. In 2003, he became Director-General of the Chancellery of Lower Saxony, making him the federal state's representative vis-à-vis the German Federation.

Between 2008 and 2014, he served as State Secretary in various ministries, including Health, Economics and Technology. He was responsible for the implementation of various laws associated with Germany's energy transition and regularly represented Germany at the European Union's Council of Energy Ministers.

In 2014, Stefan Kapferer took up an international post as Deputy Secretary-General of the OECD in Paris. In 2016, he was appointed Chairman of the Board of Directors of the German Association of Energy and Water Industries (BDEW).

Stefan Kapferer will start on 1 January 2020 at the latest. Until then, Dr Frank Golletz, 50Hertz' Chief Technical Officer, will remain interim CEO.
