Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 7,642 Elia Group shares during the period between 29 July 2021 and 30 July 2021 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 6,527 Elia Group shares.
