Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 27,768 Elia Group shares during the period between between 9 August 2021 and 13 August 2021 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 31,121 Elia Group shares.
