Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 6,252 Elia Group shares during the period between between 23 August 2021 and 27 August 2021 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 4,022 Elia Group shares.
