Purchase and sale of Elia Group shares in the context of the liquidity agreement

Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 6,050 Elia Group shares during the period between 30 August 2021 and 3 September 2021 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 11,299 Elia Group shares.
