Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 10,620 Elia Group shares during the period between between 7 March 2022 and 11 March 2022 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 10,220 Elia Group shares.
