Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 10,500 Elia Group shares during the period between between 28 March 2022 and 1 March 2022 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 10,565 Elia Group shares.
