Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 9,850 Elia Group shares during the period between between 19 April 2022 and 22 April 2022 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 5,606 Elia Group shares.
