Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 17,500 Elia Group shares during the period between between 6 June 2022 and 10 June 2022 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 15,395 Elia Group shares.
