Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 9,590 Elia Group shares during the period between between 11 July 2022 and 15 July 2022 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 10,785 Elia Group shares.
