Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 6,108 Elia Group shares during the period between between 8 August 2022 and 12 August 2022 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 7,523 Elia Group shares.
