Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 12,260 Elia Group shares during the period between between 11 April 2023 and 14 April 2023 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 11,260 Elia Group shares.
