Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 6,805 Elia Group shares during the period between between 2 May 2023 and 5 May 2023 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 7,560 Elia Group shares.
