Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 7,308 Elia Group shares during the period between between 5 June 2023 and 9 June 2023 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 8,559 Elia Group shares.
