Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 7,700 Elia Group shares during the period between between 7 August 2023 and 11 August 2023 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 6,950 Elia Group shares.
