Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 10,230 Elia Group shares during the period between between 14 August 2023 and 18 August 2023 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 10,187 Elia Group shares.
