Within the framework of the liquidity agreement (see press release dated July 29, 2021), Elia Group reports today that Exane BNP Paribas on behalf of Elia Group has purchased 4,600 Elia Group shares during the period between between 21 August 2023 and 25 August 2023 on Euronext Brussels. During the same period, Exane BNP Paribas on behalf of Elia Group has sold 6,550 Elia Group shares.
